FURTHER GUIDANCE

- Once your claim has been assessed, we will notify you of the outcome by post. If your claim is successful we will also inform your child/children’s school(s).
- Children awarded free school meals will be awarded them, under current guidance, until at least March 2022. During this period you will not need to notify us of any changes in your income.
- However, please do notify us if you move address or your child stops living with you.
- If this claim is unsuccessful but your circumstances later change to meet the above criteria, please re-apply.
- This application is only valid for the child/children listed overleaf. If you meet the qualifying conditions listed above, a new application form will be required for the following circumstances:
 - For further children reaching school age (Reception)
 - If your child/children move to a Dudley MBC school from another Local Authority
 - For further children who join your household
